## **PREPAYMENT OF DUES AND GUEST PASS CREDITS**

**Dues may be paid Annually, Semi-Annually, Quarterly or Monthly.  
Guest Passes will be distributed according to your payment option as follows:**

### **PREPAYMENT OF QUARTERLY DUES\***

1<sup>st</sup> Quarter due by January 31, 2008

2<sup>nd</sup> Quarter due by April 30, 2008

3<sup>rd</sup> Quarter due by July 31, 2008

4<sup>th</sup> Quarter due by October 31, 2008

1<sup>ST</sup> Half due by January 31, 2008

2<sup>nd</sup> Half due by July 31, 2008

### **PREPAYMENT OF ANNUAL DUES\***

Payment due by January 31, 2008

**Family and Individual Members will be credited with eight (8) Guest Passes.  
All other categories will be credited with four (4) Guest Passes**

### **DUES MAY ALSO BE PAID MONTHLY\***

**No Guest Passes**

### **NOTICE**

**Guest Passes will be distributed at the ProShop after April 1st.**

**Payment must be received by January 31, 2008 or NO passes will be received.**

**At the time of play with a guest, a Guest Pass must be turned in to the Pro Shop for each guest.**

**If a Guest Pass is not turned in, you will be charged a Greens Fee.**

**Guest Passes earned from and after January 1, 2008 will expire on December 31<sup>st</sup> of the year issued.**

**Guest Passes earned before January 2008 DO NOT EXPIRE.**

**Guest Passes are NOT TRANSFERABLE and have NO monetary value.**

**Only Golf members are eligible for Guest Passes.**

**\* If a current participant desires to withdraw or change a prepayment status, you must notify the accounting office by December 15<sup>th</sup>, 2007.**
